

# Car Seat Checklist

Please read each question carefully and circle the appropriate answer. Every car seat, booster seat, etc that is consigned must be accompanied by its own Car Seat Checklist. No exceptions.

1. Do you know the history of the car seat?	Yes – Continue	No – Not able to consign item
2. Does the seat have a label with date of manufacture and model name/number?	Yes – Continue	No – Not able to consign item
3. Was the carseat manufactured after March 4, 2008?	Yes – Continue	No – Not able to consign item
4. Does the seat have a label showing that it meets all Federal Motor Vehicle Safety Standards?	Yes – Continue	No – Not able to consign item
5. Has the seat been recalled for any safety defect?	Yes – Continue to 5b.	No – Continue to question 6
5b. Has the defect been corrected or destroyed?	Yes – Continue	No – Not able to consign item
6. Has the seat been involved in any vehicle crash, even a minor one?	Yes – Not able to consign item	No – Continue
7. Are there any cracks, bends or breaks in the plastic shell?	Yes – Not able to consign item	No – Continue
8. Has the metal frame rusted, bent or broken?	Yes – Continue	No – Not able to consign item
9. Do you have a copy of the manufacturer's instructions?	Yes – Continue	No – Obtain new instructions to place with consigned item, or you're not able to consign item
10. Does the seat have all of its parts; harness straps, harness clip, seat cover, tether, padding, shield, and bolts?	Yes – Continue	No – Obtain missing parts or not able to consign item
11. Are the harness straps worn or frayed?	Yes – Replace worn parts or not able to consign item	No – Continue
12. Does the buckle or any other metal part show signs of rust?	Yes – Replace worn parts or you're not able to consign item	No – Continue
13. When buckled, does the mechanism lock securely?	Yes – Great! Let's consign this item!	No – Replace part or not able to consign item
